Cash coins of any kind, Notes, Bonds, Securities, Travel Tickets, Coupons, Precious Stones, and Deeds of Negotiable Instruments of any kind, whatsoever are not insurable.

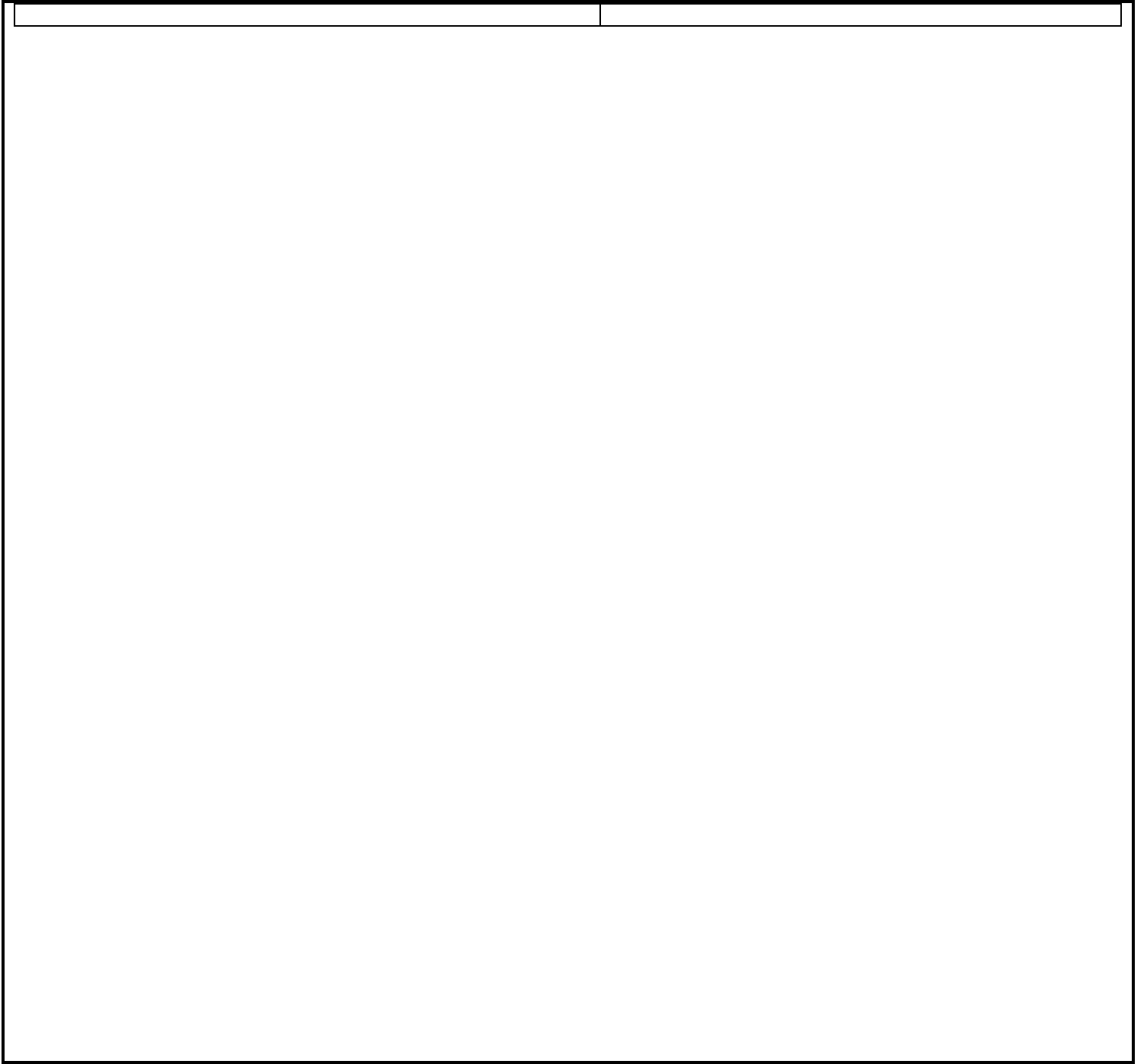
